MEMORANDUM OF ASSOCIATION

1. NAME OF THE SOCIETY :

The name of the society shall be: **VIKAS EDUCATIONAL ACADEMY**

2. REGD OFFICE OF THE SOCIETY :

The registered office of the society shall remain in the state of Telangana and at present it is at the following address:3-6-712/2, street No.12, Himayatnagar, Hyderabad-500029, Telangana.

3. AREA OF WORKING: Area of working shall be in the state of Telangana or any other place in India.

4. AIMS AND OBJECTIVES:

The aims and objectives of the society, for which the same is established, shall be as under:

- a) To establish schools of Secondary School Certificate (SSC), Central Board of Secondary Education and other patterns of school education.
- b) To establish Junior colleges, Polytechnic, Degree, Post Graduation Colleges to impart Technical & Professional education through Polytechnic, Medical, Engineering and other professional colleges/institution.
- c) To establish Teacher Training Institutions to facilitate the teaching faculty to attend seminars, symposiums, workshops and interactive sessions with eminent resource persons to enhance their abilities.
- d) To establish adult education and allied centers in villages, towns and urban areas. To Impart Education by opening night classes for both children and adults

DOCUMENT NO.2

Rules and Regulations

1. NAME OF THE SOCIETY

The name of the society shall be : **VIKAS EDUCATIONAL ACADEMY**

2. REGD OFFICE OF THE SOCIETY

The registered office of the society shall remain in the State of Telangana and at present it is at the following address : 3-6-712/2, street 12, Himayatnagar, Hyderabad – 500 029, Telangana.

3. DEFINITIONS

In these "Rules and Regulation", unless there is anything repugnant in the subject or context.

2 a) The 'Society' means:

2 b) The 'Governing Body/Executive Committee or the Managing Committee or the Managing Committee of the Society.

2 c) The 'General Body' means : - the General Body of the Society.

2 d) The executive Member means : the member of the Governing Body/Society.

2e) The 'Member' means:- the member of the General Body/Society.

2f) The 'Patron' means:- the Patron of the Society.

4. MEMBERSHIP :-

The membership of the society is open to any person who has attained the age of majority and fulfils the terms & conditions of the society but the society to the approval of Governing Body.

NOTE: The person of refusal for the membership shall be communicated to the person/applicant concerned.

5. CHAIRMAN:- He presides over all the meeting of the General Body and Executive Committee. He can cast his vote In the case of the tie in decision making. He can supervise all branches of the Society.

6. VICE CHAIRMAN :- He shall assist the Chairman in discharge his functions. In the absence of the Chairman he will perform the duty of the Chairman as entrusted by the Chairman.

7. GENERAL SECRETARY:- He is the Chief Executive Officer of the Society and Custodian of all records relating to the society and correspondent on behalf if the Society. He has to take on record of all minutes of the society would convince both the Executive Committee and General Body of the Society with the permission of the Chairman. He guides the Treasurer in preparing the Budget and Expenditure statement to place before the General Body for its approval.

8. JOINT SECRETARY :- He has to the work entrusted by the Executive Committee. He has to assist the General Secretary in discharging his duties. In the absence of the General Secretary, he can perform the duties of the General Secretary.

9. **TREASURER:-** He is responsible person for all Financial Transactions and Funds of the society. He has to maintain accounts properly along with the vouchers. He has to prepare the accounts of the society jointly with the General Secretary or Chairman.
10. **OFFICE BEARERS:-** They are the responsible persons towards doing the activities of the Society which the Executive Committee entrusted to them.
11. **QUORUM:-** Half of the total members for General Body Meeting and $\frac{1}{4}$ for Executive Committee Meeting.
12. **FUNDS:-** The funds shall be spent only for the attainment of the objects of the society and no portion thereof shall be paid or transferred directly or indirectly to any of the members through any mean. Any surplus funds available with the society shall be invested in such modes as may be specified under Section 11(5) of I.T. Act from time to time.
13. **AMENDMENTS:-** No Amendments or alteration shall be made in the purpose of the Association unless it is voted by $\frac{2}{3}$ of its members present at a special meeting convened for the purpose and confirmed by $\frac{2}{3}$ of the members present at a second special meeting and without the prior written approval of the Director of exemption, specified for this purpose under I.T. Act.1961.
14. **WINDING UP:-** In case the society has to be wound up the property and funds of the society that remain after discharging the liabilities. If any, shall be transferred or paid to some other Institutions with similar aims and Objects and which is registered U/S 12 A or Income Tax Act, 1961.
15. **BANK ACCOUNTS:-** Bank Account or Accounts shall be opened in the name of the society and the same shall be operated by such of those office bearers as may be specified by the Board from time to time.

The society shall be eligible to borrow the funds from any individual firm, company, bank or any other Financial Institution for the purpose of meeting its financial requirements.

The funds of the society shall constitute from the donations, given by the General Public, Subscriptions from the members, fees or remuneration collected from the users of the services of the Society.

The Accounts or Society shall be maintained or caused to be maintained by the Executive Committee members of the society for recording all the inflows and out flows of the society. Annual accounts shall be drawing and got audited by a Chartered Accountant before presenting the same before the General Body for their adoption or approval.

None of the office bearers of the society shall be allowed to use the funds or the assets of the society, or allowed to derive any benefit either directly or indirectly from the society stipulated U/S 13(1) (c) of I.T. Act.
